1. OBJECTIVE

Training rural households in order to provide services in rural tourism in the area covered by this project, or in the Municipality of Kozarska Dubica and Kostajnica Municipality. After completion of the training, it will be selected three household in each municipality who participates in the project (total 12), which fulfill the general and specific minimum requirements for the categorization and work.

2. BENEFICIARIES

Registered a family agricultural household, as well as an individual with members of his household, which is not registered as a family agricultural household, which provides minimum requirements for the the provision of catering services:

- 1.Rural household in the rural area which provides or planning to provide accommodation services and other tourist services in accordance with regulations in the field of tourism and catering,
- 2.Rural household in the rural area which provides or planning to provide services of preparing and serving foods and drinks and other tourist services in accordance with regulations in the field of tourism and catering,
- 3.Rural household should be decorated and equipped in accordance with traditional values, architectural heritage and rural life or the wider area where there is a rural household,
4. Preference will be given to rural households which are providing or planning to provide food and drink services within their own production (national food and drink), promotion of local and traditional

products (hand-manufactured products) and other kinds of tourist services in accordance with regulations in the field of tourism and catering as well as rural households, whose owners and holders are woman.

3.FINANCING

Training for rural households will be fully funded by the IPA Cross-border cooperation program from the project: “Una - unique resource for sustainable development”.

4. IMPLEMENTATION

Decision which establishes fulfillment of conditions for categorization of rural households shall be conducted by the Commission of the competent local authorities, made from the employees of the local government unit which is responsible for tourism and catering.
